Player / Guardian Declaration

By signing your registration form or checking the acceptance box in the online registration you are accepting the Club Rules/Terms and Conditions.

You agree to and are aware of the following:

- You are applying for registration with the Yeats United Football Club as a member.
- You are aware that the Yeats United Football Club takes insurance for public liability.
- You agree to abide by the following to which the Sligo Leitrim District & Youth Leagues /FAI subscribes (these are available at ([Sligo Leitrim District League Home \(Isl.ie\)](http://Sligo Leitrim District League Home (Isl.ie)))
 - The Rules & By Laws of the FAI.
 - The Laws of the Game of Football as governed by FIFA; and
 - The Standards outlined in the Irish Sports Commission for Junior Sport “The Codes of Conduct”.
- You have read and agree to the **Code of Conduct** (available on www.yeatusfc.com)
- You agree to allow photographs of you or your child to be used in the Yeats United Football Club’s print and online media*
- You will assist with team duties as rostered & assist in fundraising activities from time to time.
- You will make every effort to complete responsibilities to ensure the smooth running of the Yeats United Football Club.

***Online and print photo opt out** – If you don’t want photographs of you or your child to be used in the Yeats United Football Club’s print and online media please indicate your objection on the paper registration form or in the comments field of the player registration screen.

Yeats United FC/FAI Social Networking Policy

At Yeats United Football Club strictly follows the Sligo Leitrim District & Youth Leagues /FAI Policy on Social Networking. This means you need to be



aware of your responsibilities when posting to social media, e.g. privacy considerations, acceptable online behaviour and not bringing your club or the Sligo Leitrim District & Youth Leagues /FAI into disrepute. Please read the policy in full:

Player Code of Conduct

Players are asked to read & Guardians are asked to read & discuss the Players Code of Behaviour with their child/children. Outlined also are the consequences of any breaches to the code, which applies to training & games.

Code of Conduct

- Play by the rules.
- Never argue with an official. If you disagree, have your captain, coach or manager approach the official during a break or after the competition.
- Control your temper. Verbal abuse of officials and sledging other players, deliberately distracting or provoking an opponent are not acceptable or permitted behaviours in any sport.
- Work equally hard for yourself and / or your team. Your team's performance will benefit, so will you.
- Be a good sport. Applaud all good plays whether they are made by your team or the opposition.
- Treat all participants in your sport as you like to be treated. Do not bully or take unfair advantage of another competitor.
- Cooperate with your coach, teammates and opponents. Without them there would be no competition.
- Participate for your own enjoyment and benefit, not just to please parents and coaches.
- Respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion.

Breaches at Games

Any breaches at games will be handled by the Yeats United Committee.

In the event of any disciplinary action being taken by the Yeats United Committee, Yeats United Football Club will notify the Recipient, Guardian (If Recipient is Under 18 Years), Coach & Manager, by phone or in person.



Breaches at Training

Any breaches at training will be handled by the Yeats United Football Club as detailed.

The following applies to Players only.

Any other issues will be dealt with by the Yeats Committee as they arise.

IF THE CODE IS BREACHED AT TRAINING THE FOLLOWING WILL HAPPEN.

- First offence – Warning from Coach.
- Repeat offence – Sent off the field for time out.
- Serious breach – Expelled from that days training, Guardians are notified of the incident (If player is under 18 years). The club management committee will then consider appropriate disciplinary action.

Responsibilities of Parents and Players

The Club, under the Sligo Leitrim District & Youth Leagues /FAI, has adopted the Irish Sports Commission for Junior Sport “Codes of Behaviour”, the FAI Child & Youth Risk Management Strategy and the FAI Social Media Policy. This applies to players, coaches, officials, parents, administrators, volunteers, and spectators. Team Managers will have a copy of these all individuals associated with the club are asked to read & must agree to be bound by its requirements.

The Yeats United FC/FAI Code of Conduct applies to training & games. One of the most important elements of the code is to recognise that the players are there to have FUN while developing their skills and friendships. As coaches, parents, spectators etc., we need to remember this and not attempt to relive our own sporting prowess or dreams through our children so that too much pressure is placed upon them. Everyone involved with the Yeats United Football Club has a responsibility to model appropriate behaviour and relationships.

All managers and coaches at Yeats United FC are dedicated volunteers who adhere to the code of conduct mentioned earlier. It is the responsibility of parents and players to treat their position with the same level of respect as they would towards a player or official.



Privacy and Information Security Statement

The Yeats United Football Club. online and paper-based registration process requires you to provide a arrange of personal information e.g. name, birth dates, addresses etc. This information is required for registration, membership & volunteer purposes with the Yeats United Football Club (the club).

Full names and phone numbers etc will be used on Yeats United Football Club Team Lists etc. & may be used on the Sligo Leitrim District & Youth Leagues /FAI website and newsletters where appropriate or necessary, e.g. Rep Player or Player of the Year etc. The Yeats United Football Club will not make any identifying information available to any other parties without consent unless required in the ordinary operation of the Club.

Only members of the club executive/committee will have access to your full registration information.

Where is the information held?

Yeats United Football Club uses the services of Clubforce (online registration system) and Clubforce (the consulting company that manages Clubforce) to facilitate online registration and payment.

All data is securely stored by Clubforce. Yeats United Football Club maintains a copy of the information locally as an exported file and in paper-based form. Your Personal Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification or disclosure.

Providing info to third parties

Yeats United Football Club and/or Clubforce will not give any players' information to any 3rd parties except If we are required by law we will honour a lawful request by a government agent.

Club Lotto

Yeats United Football Club and/or Clubforce are committed to protecting the privacy of players' information and will not disclose it to any third parties. When necessary, details will be collected by a member of the Yeats



committee solely for the purpose of processing prizes and will not be shared with others. In the event of winning the jackpot, the prize fund will return to its base amount of €500. All payments for prizes will be made through bank transfers. It is important to note that Yeats FC cannot be held responsible for any inaccuracies in the provided bank details.

Insurance Policy

Yeats United Football Club secures annual coverage for Public Liability in order to safeguard the club. The club follows the principle that all schools provide insurance policies for students attending primary and secondary school, offering coverage for accidents that occur during any physical activities, whether inside or outside of school hours. By agreeing to the terms and conditions, you confirm that you have obtained the insurance policy provided by your local school.

Please note that Yeats United cannot assume responsibility for personal protection insurance for players, as it would result in increased insurance costs and subsequently raise the annual club fee. The only exception to this rule applies to senior teams, where the cost is passed on to individual players.
