Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 it is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, The Government of Ireland, Health Service Executive (HSE), Football Association of Ireland (FAI) and the Tipperary Southern Schoolboys/girls League have recommended many precautionary measures, including social distancing, keeping surfaces and equipment clean, hand sanitising, no hand shaking, cover mouth and nose when coughing and sneezing, avoid touching your face, as well as others. As guidelines change it is the responsibility of the parents / children / volunteers to practice the most up to date guidelines as issued by the above authorities.

Cashel Town Schoolboys/girls F.C. ("Club") has put in place additional preventative measures to reduce the spread of COVID-19; including a record of all children present at a training sessions (for future contact tracing), temperature reading at start of training sessions of all personal at a training session (people with temperatures recorded over 37.5 will be asked to return home straight away and asked to seek medical advice), however, the Club can't guarantee that you or your child(ren) will not become infected with COVID-19. Furthermore, attending the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

Declaration

I you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that myself, my child(ren), or any persons authorised by me to take my child(ren) to and from club events, may be exposed to, or infected by COVID-19 by attending the Club event, and that such exposure or infection may result in personal injury, illness, permanent disability, or death.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club volunteers, and event participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), myself, or anyone authorised by me, (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in Club programming ("Claims").

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program.
