## **Tramore Rangers FC Rules – 2025 Season**

As laid down by Management Committee



## All members shall be bound by the following:

- **1.** All junior (adult) and underage players must be registered and approved by committee before playing in official league or cup games.
- **2. (A)** Player Fees, which includes Club Membership, League registration and personal accident insurance cover, and Non-Playing Membership fee, must be paid in full by dates outlined in online payment system.
- **(B)** Match subscription per game must be paid by all players before kick-off.
- **(C)** Any player in arrears with subscriptions shall not be eligible for selection.
- **(D)** Junior League Management Committee may be notified of any outstanding monies due to the club by an individual member.
- **(E)** All player registration fees and player/non-player membership fees will be accounted for in the Club Accounts.
- **(F)** Any purchases made for, or on behalf of the Club, must be authorised beforehand by the Chairman & Treasurer or Committee.
- **(G)** 'Red Card' fines must be paid by the member who is sent off to the Committee within 5 days. Player is not eligible to play under League and Club Rules until fine is paid.
- **(H)** Players are obliged to participate in fundraising for the club and failure to do so can lead to action being taken by the committee.
- **3. (A)** Players to attend ground at least 30 minutes prior to kick-off time for all games for which they are selected.
- **(B)** Any selected player not available for a game is obliged to notify a member of team management at least 48 hours beforehand.
- **4.** All registered players are expected to give priority to all Club games for which they are required.
- **5.** All club members to be recorded on official Membership Record system (FAInet).
- **6. (A)** All nominations for the following Honorary Officer positions on Committee Secretary, Treasurer or Rule proposals/amendments, must be received in writing by Hon. Secretary not later than 14 days prior to an AGM being held (see R 14). **(B)** These Rules can only be amended or added to at an AGM.

- **(C)** The maximum number of members to comprise committee shall not exceed 13, of which, at most, five can be players.
- **(D)** Chairman to be re-/elected at the first meeting of the incoming Committee, or annually.
- **7.** For all FAI & Munster Junior Cup games, team management shall be decided by the Committee.
- **8. (A)** All players are expected to train during season under supervision of appointed trainer, unless in circumstances agreed with manager(s). Failure to attend training, without proper explanation, shall render a player ineligible for selection and may be dealt with by suspension or fine.
- **(B)** Official Club Training to be decided/approved by the Committee.
- **9.** No injury claims shall be entertained by the Committee outside of those covered by the agreed Private/League Injury Scheme.
- **10.** The Committee will decide the number of teams for each season and what leagues to enter.
- **11.** Managers to be appointed by the Committee on a two-yearly basis, subject to annual review.
- **12.** Any club member bringing the game/club into disrepute will be dealt with by the Committee and may face fine and/or suspension.
- **13.** All requests for release from club must be made in writing to the Hon. Secretary and will be considered by committee.
- **14.** A general meeting for all club members will ordinarily be convened annually, not later than July 20<sup>th</sup> or otherwise waived.
- **15.** The Management Committee's decision on all matters is final.
- **16.** Each season a copy of Club Rules shall be displayed in Home Dressing Room and online as part of the registration/payment process.
